

**PUBLIC NOTICE
REQUEST FOR PROPOSALS (RFP)
SECOND REQUEST**

The Trumbull County Department of Job and Family Services (TCDJFS) will be issuing a second solicitation of proposals for the potential purchase of Temporary Assistance to Needy Families (TANF) program services for the Federal Fiscal Year (FFY) 2016. Services requested under this solicitation will provide programming designed to assist TCDJFS in meeting the mandated TANF participation rate while providing eligible, low-income individuals and families who are residents of Trumbull County, Ohio and are in receipt of TANF benefits assistance in reaching self-sufficiency.

Prospective bidders may obtain a proposal packet beginning Monday, November 16, 2015 at 11:00 a.m. by accessing the packet to be posted in .pdf format only on the worldwide web found at <http://hs.co.trumbull.oh.us/> and choosing the link indicating "News and Events." Individual requests for proposal packets will not be accepted by TCDJFS' staff. Prospective bidders who received a preliminary award letter under the first proposal solicitation need not respond to this second proposal request unless you wish to propose a separate, unrelated program.

Awarding of contracts will be contingent upon the Federal and State allocation of TANF funding for the FFY 2016, and may be for any time during the nine (9) month period beginning January 1, 2016 and ending September 30, 2016, at the sole discretion of TCDJFS.

Completed proposals must be submitted to TCDJFS, Fiscal Office, at 280 North Park Avenue, Suite 1, Warren, Ohio 44481, no later than the **DEADLINE DATE OF 11:00 A.M. ON THURSDAY, DECEMBER 3, 2015**. Proposals received in person will be accepted through the main Customer Service Desk only. Proposals received in person or by mail on or after this date and time will not be considered. All submitted proposals must be completed strictly according to the specifications and provisions outlined in the RFP packet in order to be considered.

The attention of the bidder is directed to the requirement that upon award of a contract, the bidder must duly sign a Non-Collusion Affidavit, a Personal Property Tax Affidavit, required by Section 5719.042 of the Ohio Revised Code, and a "Sign-Off Sheet" in agreement that the terms of the "New" Drug and Alcohol Free Workplace Policy adopted by Trumbull County on 07/21/04 also apply to any contractors directly paid or reimbursed for services through Trumbull County.

Attention is also directed to all bidders that pursuant to Ohio Revised Code (ORC) Sections 307.86 and 307.87, effective September 26, 2003, this notice of bid is required to be published only one (1) time not less than two (2) consecutive weeks preceding the day of the opening of bids in a newspaper of general circulation within the county as the notice meets all other requirements defined in Ohio Revised Code Section 307.87(A) and will also be will be distributed by electronic means, with the posting of this notice on the TCDJFS' internet site on the worldwide web and found at <http://hs.co.trumbull.oh.us/> and can be accessed by choosing the link indicating "News & Events." TCDJFS shall also post and maintain a copy of this notice on its public bulletin board in the TCDJFS' main lobby beginning with the initial date of media publication through the duration of the proposal acceptance period.
