ON WEDNESDAY, SEPTEMBER 24, 2014**. Proposals received in person or by mail on or after this date and time will not be considered. Proposals received in person will be accepted at the TCDJFS' main customer service desk only. All submitted proposals must be completed strictly according to the specifications and provisions outlined in the RFP packet for the proposed service in order to be considered.

The attention of the bidder is directed to the requirement that upon award of a contract, the bidder must duly sign a Non-Collusion Affidavit, a Personal Property Tax Affidavit, required by Section 5719.042 of the Ohio Revised Code, and a "Sign-Off Sheet" in agreement that the terms of the "New" Drug and Alcohol Free Workplace Policy adopted by Trumbull County on 07/21/04 also apply to any contractors directly paid or reimbursed for services through Trumbull County.
